1. OBJECTIVE OF THE COMPETITION

To remind the sporting public the person of Štefan Banič - inventor of parachute, to promote sport parachuting, and determine winners in the following disciplines:

- a) landing accuracy of individuals,
- B) landing accuracy of three(two)-person teams.

4. PROGRAM

Saturday 6/8/2019 9:00 AM registration closes 9:00 AM - 10:00 AM - technical conference and official opening of the competition 10:00 AM - 8:30 PM - competition jumps 9:00 PM - award ceremony

Sunday 6/9/2019 weather day

5. TERMS OF PARTICIPATION IN THE COMPETITION

All participants are required to have the FAI sport license and a valid membership card of the Slovak National Aeroclub or the international FAI license. Parachutists must be holders of B-license or higher.

Jumps may be conducted only with appropriate specialized accuracy canopies. The Load Organizer and the Head Judge shall decide on participation of holders of lower license or on use of other than accuracy canopies. All participants shall be obliged to provide proof of having done a minimum of 5 jumps in the last 2 months on the particular canopy type.

Foreign nationals may conduct jumps only with a valid license issued by the competent national aeronautical authority or an authorized authority thereto in their country, and on rigs for which the participants set forth the documentation that authorizes operational suitability of reserve canopies and AADs.

They shall be obliged to refer to provisions valid in the territory of the Slovak Republic when conducting parachute jumps. Person responsible for the use of canopies and AADs including the inspection of parachutists before boarding the plane shall be the head of the team or individual parachutist, provided that the parachutist holds at least B-license or sufficient performance rating, which shall be confirmed by executing the designated statement (attached hereto). Participants shall have a personal insurance or rig insurance that covers damages caused by parachuting in the territory of the Slovak Republic.

6. GENERAL RULES

The competition shall run pursuant to regulations of the FAI for classic disciplines with the following exceptions:

a) number of jumps for individuals and teams:

All participants should complete 4 rounds of jumps in teams. Achieved results shall be assessed for both individuals and teams. Jumps will be conducted to a 2 cm zero.

Minimum requirement for the competition is 1 round.

In case of equality of results in the first three places the provisions of regulations FAI are to be followed (to be specified at the technical conference).

b) protests

a protest shall be delivered to the director of the competition no later than 30 minutes from the occurrence of the event in question with the reference to regulations including a EUR 15 fee. In case the protest is recognized and accepted the fee shall be returned.

- c) except for the discipline Accuracy Landing pursuant to official FAI rules there will be a discipline for interested participants with a hand measurement up to 25 meters.

 This discipline shall be divided into 2 categories:
- members of the Club of Paratroopers (KVV),
- others (not members of KVV).

Other deviations from the competition rules of SNA and current FAI regulations for the given discipline will be announced at the technical conference.

The organizer may regulate and correct the number of registered participants in order to provide the best efficiency and meet the capacity limits of the competition.

7. Announcement of results and award ceremony

Individuals and teams placed in the first three places will receive a cup, medal and prize in kind.

8. AIRCRAFT

AN-2 or L-60S

a FFFS

registration fee for individual: EUR 10,

competition jump for Accuracy Landing from 1200m: EUR 15.

10. ACCOMMODATION / CATERING / OTHER

a) accommodation in the premises of AK Trnava: possibility to use a limited capacity in the dorm upon individual agreement

b) catering:

- catering possibilities of the airport buffet will be specified later,
- organizer shall provide participants with a hot meal during the competition day.

11. JUDGES

Head Judge and other Judges will be introduced on the technical conference.
